The Organic Research Centre left for Cirencester in January, with neither ceremony nor farewell to Hamstead Marshall after 40 years' residence at Elm Farm.

Carter Jonas' sale of the centre's former property in the village appears to be complete, save for the last parcel of 47-acres (lot 7 in the brochure) now with the added farm cottage, which is subject to agricultural occupancy. The guide price is £650,000, and at least two or three parties are thought to be interested.

Meanwhile the buyers of Lot 1 — the farmhouse, yard, barns and buildings with 48 acres on the south side of Kintbury Road — are identified in a planning application as Mr and Mrs D Oppenheim. Their application seeks to convert the former ORC research laboratory and offices to a four-bedroom house. The plans posted online indicate that this applies to the easternmost range of the yard buildings, with no extensions or demolitions proposed.

The ultimate fate of the Grade-II listed barn, which has hosted so many village markets and festivities over the years, and the unlisted four-bedroom farmhouse (for which ORC obtained still-valid permission for use as a dwelling) is unclear.

The White Hart closed its doors again before Christmas, so villagers were more than ready for a pub night in the village hall on 28th February. About fifty people came to the hall to enjoy a pint of Mr Chubb's, wine, soft drinks, snacks and a variety of table games including David Harris' popular shuffleboard.

Another pub evening is planned for Friday 27th March.

### Fourth attempt to build on former Sovereign garages site

Undeterred by three failed attempts by previous owners to gain planning permission, Dreamlodge Ltd has submitted an outline application to build a two-storey house on the plot alongside no. 1, The Village.

The site was formerly owned by Sovereign Housing Association, and accommodated garages for social housing tenants. In 2005 Sovereign sold the site, much to the discontent of local residents for whom no alternative parking provision was made.

The first buyer, Lodge House Ltd, was denied building permission in 2006, and in 2007/08 two further applications made by Templegate Ltd foundered.

Dreamlodge Ltd is registered at Hamstead Park, and is the company through which Tim Gwyn-Jones bought the Craven estate at auction in 1984.

When will **WBC** do something about fly-tipping?

First it was the old mattresses (and more) in the former gravel field in Park Lane. Being inside the fence, this was on private property, but councils do have the authority to enforce clearance. Then, because one dump inevitably attracts more, two bags of builders' rubble appeared outside the gate, on highways department land. One bag was subsequently tipped out, and an old radio was added. The latest arrival is a dead Christmas tree.

WBC and the parish council have been kept abreast of this unfolding story, with photos, to no result so far. The most recent response quoted yet another reference number, saying that "the enquiry is now closed" because it "should be resolved within the next four to six weeks."

By that time, if anything is done, the problem may have increased.

The man who named our village



William Marshal, the Anglo-Norman nobleman who gave our village its name, died 801 years ago this year. A move is afoot within the village to organise some kind of physical commemoration of him within the village, to let people know who he was and why he was important. It's felt that such a move could add to Hamstead's identity, following the loss of the pub and Elm Farm.
