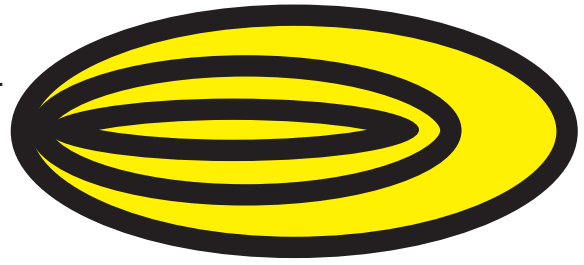

## Hamstead Marshall Wildlife Group

In April a village wildlife group was launched by Anne Budd, Susie Aromando and Rob Manser, with the aim of supporting local habitats and wildlife, and promoting good management of Hamstead's natural environment.

The group has two social media accounts:  
a Twitter account;

a Facebook page currently with 21 members. There's an open invitation for people in Hamstead Marshall to join, share photographs and promote wildlife causes. To join, contact Rob Manser.

A habitat-mapping project is underway, recording several local areas. Penny Stokes, Sarah and Mick Ward and Anne and Alan Budd are currently helping to create a permanent record of habitats and wildlife within the parish. To date, more than 137 different species of wildlife have been



noted, and this data is being regularly uploaded by Anne to the Department for Environment, Food and Rural Affairs (DEFRA) via their interactive mapping website MAGIC, and the Thames Valley Environment Record Centre. (No personal information is recorded.)

Anne Budd has sought and obtained endorsement of the project from several national organisations, including Natural England, whose data manager Marvin Dohm said *"It is wonderful to see your group looking at best practice in achieving local nature conservation"*.

## 2021 Annual parish assembly

Hamstead Marshall's 2021 parish assembly was held as a face-to-face meeting in the village hall on 20th May, immediately followed by a parish council meeting. Four parish councillors, the parish clerk, two district councillors and two parishioners attended.

The **new parish clerk**, Sarah Jones, was welcomed, her predecessor having left to become deputy editor of the *Newbury Weekly News*.

In the absence of any other volunteers, John Handy will continue as **chair of the parish council**, but he announced his wish to stand down next year. Anne Budd agreed to serve as vice-chair if Peter Benest does not wish to continue.

Last year's assembly having been missed due to covid, the chairman paid **tribute to the volunteers** who have sustained village life and activity during the lockdowns, collecting and delivering food parcels and medication for the housebound, organising the making of scrubs and cakes for the NHS and local care homes, and running the pop-up shop which continues to supply villagers with local produce. Gratitude was also expressed to parish councillors, district councillors, parish planners and

the village hall committee for their efforts in the past year.

**Thames Valley Police** was not represented, and the report had not been brought, but it was believed that there has been very little local crime lately.

The **ACV (Asset of Community Value) status** obtained for the White Hart is soon to expire and needs renewing. Susie Aromando has taken it in hand.

**Enborne School** has worked hard during lockdown, catering for the children of key workers and supporting home schooling. A donation of £300 was raised by a sponsored walk.

Concern was expressed for **development pressure on the countryside**.

The **Relief in Need** (an old-established village charity) field is excessively wet and needs draining, but is too small to qualify for a grant.

The **parish council website** needs updating, but the clerk has had problems uploading data.

The **anti-speeding campaign** initiated by Rob Manser and Olivia Comier is on hold.

## Village hall news

The village hall has been kept financially afloat over the past year by government grants and reimbursement of business rates. Thanks to this and a regular maintenance schedule, the hall is in good financial and physical shape.

The committee is to meet on the 22nd June to discuss reopening of the hall subject to covid regulations.

The (alternate) Thursday morning pop-up shop will continue through June and probably July, supplying eggs, bread, Lanie's preserves, Tony's cheese, apple juice and the *Newbury Weekly News*. John Handy continues to take occasional Ramsbury beer orders via the community Whatsapp.

The flooding in the village hall car park may finally be remedied now that it has been confirmed that West Berkshire Council bears responsibility. John Handy is pushing for action. Once the water stops flowing the committee will be looking to claim on insurance for the surface to be repaired.

### Two Whatsapp groups currently keep villagers in touch:

**Community Support Chat** was set up by Sarah Stevenson at the beginning of the first lockdown to keep parishioners informed about covid, and to take village shop orders, but it has now widened to include chat about lost and found, items for sale or loan and general local observations. ## Good Hope Farm

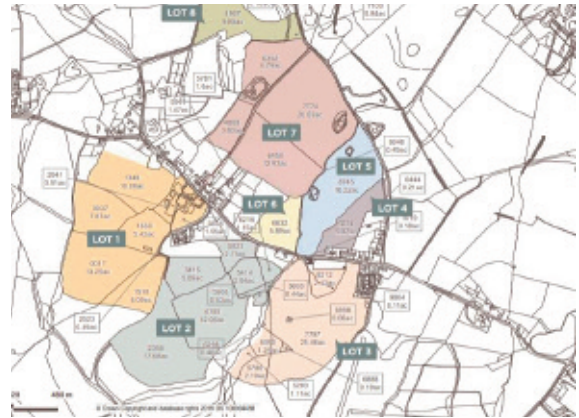
The mystery of who bought the former Elm Farm field in the dip on Park Lane (Lot 6, right), and for what, can now be revealed.

The field is being converted into a small farm as a therapeutic project for learning-disabled young adults. The enterprise is called Good Hope Farm, and is planned to be a day centre offering workshops to schools and groups, who can visit and learn within a soothing natural environment, where cultivation is sustainable and wildlife diversity promoted.

Good Hope Farm is currently aiming to raise £7,100 through the Good Exchange for a greenhouse classroom. So far, £2,120 has been raised with match funding from Greenham Trust. See [here](#) to donate. Longer term plans include a wildflower meadow, a farm shop, and possibly animals such as chickens, alpacas and goats.

Good Hope Farm is not a charity, but a community interest company (CIC). The company was registered in 2015 as being for the benefit of adults with learning disabilities and the community. The two directors of Good Hope Farm, Karine Giannamore and Kishan Parekh, live in Buttermere, and they previously set up a Good Hope Farm near Marlborough.

The organisation has a website on <https://www.goodhopefarm.org.uk>, which was running up to 9th June, but it currently appears to be inaccessible.



**news in brief** **The White Hart** looks forward to summer with the launch of a new beer: Saviour Sanity, described as “a modern golden beer ... benefiting from a high level of wheat malt and the new Azacca hop from the USA...refreshing, with sustained citrus and mango notes and tropical fruit overtones. The Sauvignon Blanc of beers.” The alcoholic content is 3.7 per cent.

The inn is currently open Mondays to Thursdays 17.00 to 22.00, Fridays and Saturdays 12.00 to 22.00, Sundays, 12.00 to 17.00. Food is served from Wednesdays to Sundays.

**Hamstead Marshall's revised parish plan** has now been accepted by WBC, although it has yet to surface on the council website. It will soon be available for all to read on the village website.

The **mobile library** continues to call at Ash Tree Grove every third Thursday morning from 10.40 until 11.10. Dates for the next few weeks are: 24th June; 15th July; 5th and 26th August; 16th September. You can choose and order books from the online catalogue. **Covid test kits (lateral flow) for home use** can be collected free from the mobile Community Collect service which calls at Hamstead Marshall village hall each Friday from 09.15 to 10.15.

**HAMSTEAD MARSHALL.**—At a meeting of the long-established Benefit Society of this pleasant village, for the septennial division of their funds, (a dinner having taken place, capitably supplied by the Host of the White Hart Inn,) the pleasing ceremony took place of presenting to their worthy leader and treasurer, Mr. James Cokes, a valuable gilt clock, subscribed for by the members, and bearing the following inscription:—“Presented to Mr. James Cokes, by the Members of the Hamstead Marshall Benefit Society, as a token of their esteem and gratitude for his valuable services rendered to the Society for many years. April 25th, 1864.” The testimonial was presented in a neat and flattering speech by the secretary, Mr. James Elkington, amidst the hearty cheers of the members, and Mr. Cokes having returned his best thanks and his wishes for the future prosperity of the society, a most convivial evening was spent, all appearing pleased with the events of the day.
