## Footpath still inaccessible to some walkers

**A growing chorus of complaint is now supporting David Harris' campaign for the restoration of a gate on the footpath leading from the Kintbury Road just east of Ash Tree Corner to the main drive into Hamstead Park.**

The former gate was replaced some months back by a stile, which has effectively closed the path to some less able-bodied walkers. David Harris wrote to WBC asking what pressure might be exerted to get the gate restored, but was told that the local authority had no power to enforce this.

Nonetheless, a letter was sent by WBC to the landowner, Rollo Gwyn-Jones, requesting restoration of the gate. This resulted in a change, whereby a hatch was installed beside the stile (pictured below), presumably to enable dogs to get through. This was obviously of no help to walkers of limited mobility.

David Harris has since been collecting comments from local walkers who regret the loss of access:

- *As a couple who are getting older but still enjoy our local walks, we would much prefer to have a gate installed...*
- *I find stiles are particularly difficult...*
- *Since the removal of the gate and its replacement with a stile, it is no longer suitable for some of [my friends] due to their mobility issues...*
- *I have a problem with arthritis...the gate was not a problem for me but this stile certainly is...*
- *Reinstatement of a gate would be enormously beneficial to my enjoyment of the local countryside...*
- *Having the gate reinstated would mean complete access on our favourite and very popular circular walk around the area.*

With the landowner's permission, a volunteer team is available to instal a kissing gate, which would prevent any risk of livestock straying.

*The Hornet* has written to Rollo Gwyn-Jones asking for comment, but no reply has so far been received.

Replacement of existing timber windows which were installed in the 1980's with similar timber windows incorporating slimline double glazing and draught proofing

Refused 26th Jul 2022 "Insufficient information has been submitted with this application to demonstrate that the proposed development would conserve and enhance biodiversity and protected species on site."

#### **Enborne Equestrian Centre, Holtwood RG20 OJL**

22/00652/COMIND validated 14th April 2022.

Conversion of existing barn into habitable visitor accommodation. Remove existing mobile homes and other structures – replace with staff accommodation, various rooms, kitchen, tea room and wcs.

#### **Fishery Cottage RG20 OJD**

21/02912/FUL validated 1st December 2021.

Section 73 application to vary/remove conditions 2 (plans) and 3 (materials) of approved application 20/00320/FUL: Demolition of current dwelling to be replaced with larger dwelling. Shortening of the southern fish pool. Demolition of the barn, to be replaced with a new barn of the exact design and size.

Construction of a new farm access track, parking area and the installation of temporary structures in association with the provision of a daily care farm facility.

Hamstead Marshall Parish Council had added its voice in objection to some extensive changes and additions to Lake House in the neighbouring parish of West Woodhay. Described as a substantial detached house in 1.4 hectares of landscaped gardens, this property, formerly known as Haywood Green Farm, has been the subject of several recent applications and appeals. The latest seeks to add a 1,500 square metre underground car park for 16 cars, a swimming pool, sauna, gym, games room and "wellness areas".

## From the parish council update issued at the end of July

Information recently obtained on **SID**, the scheme whereby parishioners can monitor speeding traffic, includes the following:

- the hand-held device is lent to parishes at no cost, and the loan can be permanent if it is to be used on a regular basis;
- registration of the scheme has been simplified;
- training is on-line only.

The parish council has set up a **pot-hole database**, to which parishioners are invited to submit information. The previous system of individual parishioners notifying WBC has proved unsatisfactory, but the new database will be updated with details of the current status of all pot-holes in the village, and a report will be sent to WBC every six weeks. Ash Tree Corner has already been pinpointed as a potential hazard because of verge erosion and subsidence.

Send details of your pet-hate pot-hole to Anne Budd. A photo would be helpful, as would a [what3words](#) reference locating the pot-hole exactly.

Judgment is still pending on a case between Wiltshire County Council and Earthline, owners of the **proposed quarry above Craven Keep**. No news is expected in the immediate future.

The **Village Design Statement** drawn up and lodged with WBC in 2007 is under review, and the parish council would welcome input from parishioners.
